



## Attachment B: Scope of Registration for Crimped Swagelok UT series PFA Hose Assemblies (Category D)

This document represents the scope of the Swagelok Coreflex UT series hose and crimped assemblies covered by this submission for CRN approval. These products have been evaluated in accordance with the Association for Rubber Products Manufacturers (ARPM) Hose Handbook. U-Series hose assemblies have 2 possibilities for crimp collars; current standard and “Megafang” designs. Please see tables 1 and 2 below, and the “Configurations” section for description of differences between the two designs.

**Product Description**

The Swagelok UT series is standard Swagelok virgin PFA-lined hose with a silicone reinforcement layer, 302 Stainless Steel reinforcement, and a silicone cover. All UT series hoses undergo production testing in accordance with ASTM D380 “Test Methods for Rubber Hose” (version current to hose production date).

**Configurations**

All end connection inserts are crimped onto the hose using crimp collars. The U-Series hose crimp collars have two designs: the standard crimp collar available in 1/2", 3/4" and 1" sizes, and an upgraded design named "Megafang" which has shown more robust performance (1/2", 3/4" and 1" sizes noted in Table 2 to be widely available in 2021). Assemblies for both crimp collar designs noted above follow the same method of assembly and materials of construction. See photos below for visual differences between standard crimp collars and Megafang crimp collars.

**Product Options:**

Additional options that do not affect pressure and/or temperature ratings may be made available and are within the scope of this approval. Examples of these would include, but not limited to, the following:

**Cover Options**

- Armor guard - Interlocking, flexible 302 stainless steel.
- Fire jacket - Woven fiberglass coated with specially compounded aerospace-grade silicone rubber
- Spiral guard - Helical HDPE plastic

**Tag and Marking Options**

- Mat tag - Polyester tag with customer-specified text
- Lanyard tag - Stainless steel tag with customer-specified text

**End Connection Seals or Sealants Options**

- VCO – O-rings
- Pipe Thread ends – thread sealant
